Lorton's Attic Consignment Regulations

Consignments are accepted by appointment only.

- Appointments may be scheduled Tuesday's 10:00 a.m.-4:00 p.m. and Thursday's 10:00 a.m.-1:00 p.m.
- Appointment must be scheduled with the store manager, Melissa Deutsch, at least one (1) day in advance.
- Call (703) 339-5161 ext. 130 to schedule an appointment.
- If items to be consigned include furniture please be prepared to discuss them when scheduling an appointment. At this time clothing will not be accepted for consignment. Please provide pictures of your items by emailing them to Melissa@LortonAction.org.

Consignment Fee - \$20.00 for 365 days.

Payable at first consignment by cash or credit card.

Percentage - 50% of the sales price to the consignor.

Consignment Period - 60 days

Unsold items may be picked up on or before the end of the 60 day consignment period. **Unclaimed items become the property of the shop.**

Items accepted for consignment

We accept three (3) items for consignment per appointment. It is the consignor's responsibility to have items to be consigned delivered to the shop. All items must be clean and in good condition with no rips, chips, cracks, tears or stains. Before an item is accepted it will be inspected. We reserve the right to reject consigned items found to be defective or otherwise unsalable. Each item must be worth **\$10.00** or more.

- Furniture - accepted on a space available basis. We do not accept entertainment centers.
- Electronics – Items must be in working condition and include all bulbs, batteries, cords and connectors required for operation. TVs accepted for consignment must be flat panels.
- Decorative household items (lamps, wall art, table accents, candles, etc.)
- Cookware
- Glasses in matched sets of six (6) or more
- Serving pieces (bowls, platters, etc.)
- Flatware in complete sets of four (4) place settings or more
- Dinnerware in complete sets of four (4) place setting or more

Payment - consignors will be paid monthly for goods sold.
